Papua New Guinea holds the status of an autonomous nation within the southwestern Pacific region where neighboring Indonesia borders its western territories and Australia and Solomon Islands establish its maritime parameters. Papua New Guinea functions as the largest Pacific island country and the most populous nation in that region since it encompasses 462,840 square kilometers and has an estimated population of 9 million in 2024. Papua New Guinea stands out among international nations through its multiple cultural roots and many languages and large natural resource base.

### 1.1 The Path to Independence

PNG operated under colonial administration for 100 years until it obtained its independence. Under German authority New Guinea became colonized first in the 1880s followed by British rule of Papua beginning from 1884. World War I caused Australia to assume territorial control of both regions which became a United Nations Trust Territory administered by Australia after World War II.

The political awareness of that era drove more people to seek full control over their governance. PNG made significant progress toward political inclusiveness when the Legislative Council came into existence in 1951 followed by the House of Assembly in 1964. The local leadership transition received a landmark moment when Sir Michael Somare assumed the role of PNG's first Chief Minister in 1972 leading the nation toward complete independence. On September 16, 1975 PNG announced its independence from Australian administration becoming a sovereign nation.

### 1.2 The Significance of Independence

PNG entered a historic period of independence that let the nation shape its politics together with its economic direction. PNG set itself apart from other post-colonial settlements because national independence shifted toward peaceful territory with little opposition. The process of nation-building became complicated because the country faced complications from its fragmented geography and numerous cultural groups combined with insufficient basic infrastructure. Since adopting Westminster parliamentary democracy PNG has encountered governance challenges caused by coalition politics besides leadership volatility as well as spatial tensions among its regions.

PNG faces severe economic and political instability due to its poor standing in global perception ratings.

Healthcare and education together with electricity access remain minimal as 80% of PNG's inhabitants reside in rural areas.

Tipo and Law and Order Concerns continue to be major societal problems because crime exists alongside tribal conflicts which merge with gender-based violence throughout the country.

The economy faces instability due to its excessive dependence on mining together with oil exploration since these extractive industries expose the nation to international market fluctuations.

II. HISTORICAL CONTEXT AND POLITICAL EVOLUTION

2.1 Colonial Rule and Path to Independence

In the beginning of the 19th century New Guinea operated under German rule in its northern areas while British authority governed the southern part of Papua. Australia gained control of both areas during World War I before ASEAN became responsible for administering PNG through United Nations Trusteeship during World War II.

The forming of local political institutions became possible because of rising political awareness throughout the 1950s through the 1960s.

- 1951: Establishment of the Legislative Council, with limited local participation.
- 1964: Formation of the House of Assembly, increasing indigenous representation.

Sir Michael Somare took office as Chief Minister during 1972 to defend complete independence.

On September 16 1975 PNG received its official declaration as an independent nation from the world.

2.2 Political and Governance Analysis

Due to regular changes in government power through coalition political alliances along with multiple votes of no confidence PNG has maintained this political arrangement since independence in 1975. The country has been headed by more than ten prime ministers since 1975 and coalition governments have repeatedly caused unreliable direction.

III. ECONOMIC DEVELOPMENT AND CHALLENGES

- The Wafi-Golpu Gold Project and Papua LNG Project under development will enhance revenue growth according to projections.

The sector remains in the spotlight for completely trashing ecosystems together with pushing away native residents from their homes and improper management of funds from resource extraction operations.

3.1.2 Agriculture and Fisheries

Agriculture keeps status as the largest employer while more than eighty-five percent of the population works in subsistence farming and cash crop production. Key agricultural exports include:

- Coffee (major export, especially from the Highlands region).
- The coastal area produces cocoa which establishes itself as a major income producer for the economy.
- Palm oil exists as one of PNG's fastest-growing industries.
- Copra and rubber (traditional exports).

The fishery sector of PNG operates as one of the world's biggest tuna fisheries which adds over \$1 billion annually to the economy.

The agricultural industry shows promise but struggling export capacity and reduced productivity result from inadequate road systems and minimal marketplace access alongside climate change effects.

### 3.1.3 Tourism and SMEs

PNG presents excellent prospects for tourism expansion because it offers various natural abundance alongside cultural heritage events and active travel destinations such as Kokoda Trail and coral reefs and indigenous cultural heritage attractions. The growth potential of the tourism sector remains restricted because of bad infrastructure and safety risks and expensive travel expenses.

Small and Medium Enterprises (SMEs) are expanding across PNG however they encounter several obstacles including restricted monetary access coupled with elevated running expenses and complex administrative restrictions.

PNG's GDP growth has fluctuated due to its reliance on commodities and external investment.

- **Roads:** Only 3% of PNG's roads are paved, making transportation costly.

- **Internet and Telecommunications:** Internet penetration remains below 20%, limiting digital opportunities.

#### 3.3.3 Governance Issues

- Mismanagement of resource revenues, reducing funds for public services.
- Weak law enforcement, allowing fraud and misappropriation of government funds.
- Low transparency in business contracts, discouraging foreign investment.

#### 3.3.4 High Unemployment and Skill Gaps

- Youth unemployment exceeds 30%, leading to social instability.
- Limited vocational and technical training programs, restricting workforce development.
- Many educated professionals seek opportunities abroad, creating a brain drain effect.

While urban areas have seen growth, rural communities lack access to basic services, leading to:

5. **Financial Inclusion** – Improve access to banking, microfinance, and business capital for rural communities.

With effective governance, investment in human capital, and infrastructure development, PNG can achieve sustainable economic growth and improve livelihoods for its citizens.

## 4.2 Healthcare System in Papua New Guinea

Healthcare in PNG remains a major challenge, with limited access, underfunded facilities, and a shortage of medical professionals.

### 4.2.1 Structure of the Healthcare System

PNG has a three-tier healthcare system:

- Primary Health Services: Rural health clinics and community health posts.
- Secondary Health Services: District and provincial hospitals providing specialized care.
- Tertiary Health Services: National hospitals offering advanced medical treatment.

### 4.2.2 Achievements in Healthcare

- Expansion of Rural Health Centers: Over 700 rural clinics established.
- Reduction in Infant Mortality: Infant mortality decreased from 64 per 1,000 live births in 1980 to 38 per 1,000 in 2024.
- Improvements in Immunization: Vaccination rates for polio, measles, and tuberculosis have increased.

- Increase in Life Expectancy: Average life expectancy has risen from 54 years in 1980 to 65 years in 2024.

### 4.2.3 Challenges in Healthcare

PNG faces significant obstacles in delivering quality healthcare:

- Limited Medical Infrastructure: Many hospitals lack proper equipment and medicines.
- Shortage of Doctors and Nurses: PNG has only 1 doctor per 17,000 people (WHO recommends 1 per 1,000).
- High Maternal Mortality Rates: 215 deaths per 100,000 live births, one of the highest in the region.
- Poor Rural Healthcare Access: Over 80% of PNG's population lives in rural areas with limited medical services.
- Communicable Diseases: High prevalence of malaria, tuberculosis, and HIV/AIDS.

### 4.2.4 Recommendations for Healthcare Improvement

To strengthen PNG's healthcare system, the following measures should be prioritized:

1. Increase Healthcare Budget: Allocate more resources to hospitals and clinics.
2. Expand Medical Training Programs: Train and retain more healthcare professionals.
3. Public-Private Partnerships: Encourage investment in health infrastructure.
4. Mobile Health Services: Use mobile clinics and telemedicine to reach remote areas.
5. Preventive Healthcare Programs: Promote sanitation, vaccination, and maternal health services.
